Purchase of the complete functional supply of the entire cable system connecting Orehoved (ORH) – Vordingborg Nord (VONØ) substations consisting of approximately 42 km single core 145 kV XLPE underground cable and approximately 14 km 145 kV submarine cable including approval of design, fabrication and factory testing, cable accessories, transport of land cable and accessories, transport of submarine cable and accessories to a harbour in Zealand, supervision of cable laying, installation of joints, terminations, transition joints and hang offs.

Objective criteria for choosing the limited number of candidates:

If more than 3 applicants fulfill the minimum requirements, cf. section III, the Contracting Authority will prequalify the 3-5 applicants who are evaluated as most qualified for the specific tendered assignment. Only these applicants will be invited to submit a tender. The selection of the applicants will be based on the relevance of the submitted references, cf. the scope stated in section II.2.4, and the extent to which the references overall

demonstrate comprehensive experience with deliveries comparable to the tendered assignment regarding solution, complexity, and scope, especially concerning:

- Voltage level, length of cable route, cross section, tasks performed (e.g. design, fabrication, factory testing, supply, transport, construction (civil works not included), installation (joints, link boxes), completion, site testing, commissioning.
- Electrical stress level of performed type test(s) of the electrical power cable in accordance with IEC or equivalent (higher stress level at inner semi conducting layer will be evaluated positively).
- Experience with work conducted in following climate conditions:
 - o Temperate climate will be evaluated positively whereas tropical, subtropical, and polar climate will be evaluated negatively.

The applicant must confirm the economic ability in the ESPD part IV.B: "Economic and financial standing" with information from the latest annual report regarding the following economic indicators:

1. Equity (total equity incl. share capital, reserves, revaluation, retained earning etc.)
2. Equity ratio (equity/total assets). This must be stated with two decimals.

If the applicant is relying on the capacities of one or more other entities (e.g. a parent or sister company or a subcontractor) or the applicant is a group of economic operators (e.g. a consortium) the information for the ESPD part IV.B must also be given in a separate ESPD from each of these entities, cf. section VI.3 "Additional information". It is the sole responsibility of the applicant to secure that the minimum level(s) of standards required are reached on the basis of consolidation when the applicant is relying on the capacity of other entities or when the applicant is a group of economic operators (e.g. a consortium).

Equity ratio from the latest annual report must, at the time of prequalification, be at least 20 pct. If the equity ratio is between 15 pct. and 20 pct. the applicant can qualify, if Equity exceeds EUR 24,590,000

III.1.3) **Technical and professional ability**

List and brief description of selection criteria:

The applicant can include up to 3 most comparable and relevant references for both submarine and landcables undertaken in the past three (3) years as part of the application.

The references must be stated in the ESPD part IV.C: "Technical and professional ability". Undertaken in the past three (3) years implies that the reference must not have been completed prior to the date reached when

counting 5 years backwards from the submission date for prequalification. References older than this will not be taken into consideration.

References which have not yet been fully completed can be included as part of the application, but if this is the case, the applicant must describe the parts which have not yet been delivered, and this may affect the evaluation of the applicant, cf. section II.2.9.

The references should include a specific description of the work performed for each reference, including:

- 1) voltage level
- 2) type test conducted according to which standard
- 3) description of cable, cross-section, and installation environment
- 4) length of land & submarine cable,
- 5) year of production,
- 6) year and place of delivery/installation
- 7) contract value (if possible),
- 8) contact information for the entity in question (including contact person),
- 9) date of initiation and final delivery (day, month, year).

Any ambiguities and/or incomprehensibilities concerning the above information may have a negative effect on the selection of candidates, cf. section II.2.9. Please note the "description" box can contain more text than is visible. I.e. it is possible to copy paste text into the box.

If the applicant is relying on the references of one or more other entities (e.g. a parent or sister company or a subcontractor) or the applicant is a group of economic operators (e.g. a consortium) the information for the ESPD part IV.C must also be given in a separate ESPD from each of these entities.

The number of references should not surpass a maximum of the 5 most comparable and relevant references.

If the applicant is relying on the capacity of one or more other entities (e.g. a parent or sister company or a subcontractor) or the applicant is a group of economic operators (e.g. a consortium) the maximum number of references to be submitted must still be respected and cannot exceed 5 when combined. If more than 5 references are submitted, the Contracting Authority will only consider the 5 most recent references determined by date of final delivery (in this case not yet finished references will not be included)

Minimum level(s) of standards possibly required:

It is a minimum requirement that the application contains at least 1 reference for submarine cable and 1 reference for land cable, both with a voltage level of minimum 145kV. The minimum requirement is also met if the application contains 1 reference that includes both submarine and land cables, both with a voltage level of minimum 145kV.

The applicant must submit a completed version of the ESPD.

VI.4.3) Review procedure

Precise information on deadline(s) for review procedures:

Complaints regarding a candidate not being pre-qualified must be filed with The Complaints Board for Public Procurement within 20 calendar days starting the day after the contracting authority has sent notification to the candidates involved, provided that the notification includes a short account of the relevant reasons for the decision.

Other complaints must be filed with The Complaints Board for Public Procurement within:

1. 45 calendar days after the contracting authority has published a contract award notice in the Official Journal of the European Union (with effect from the day following the publication date);
2. 30 calendar days starting the day after the contracting authority has informed the tenderers in question, that the contracting authority has entered into a contract based on a framework agreement through reopening of competition or a dynamic purchasing system, provided that the notification includes a short account of the relevant reasons for the decision.
