Experienced manufacturers (Company) capable of design, manufacturing and furnishing of Turbine Island (TI) Equipment scope of work (described below), must (i) update your Company's information in Bechtel's iSupplier portal at link and (ii) complete the Poland Prequalification Questionnaire with sufficient detail, for Bechtel evaluation even though you may have previously submitted this information for other projects with Bechtel.

Upon Bechtel's evaluation of your response to the Poland Prequalification Questionnaire, Bechtel will notify if your Company meets, conditionally meets, or does not meet the prequalification requirements that closely match the requirements. Your Company's submission of Prequalification Questionnaire does not automatically qualify your Company to be a prequalified Supplier.
 5. Each prequalified Supplier will be required to execute a Non-Disclosure Agreement (NDA). Companies meeting the prequalification criteria and who have executed the NDA will be invited to submit the proposals for Tion Questionnaire in Bechtel's iSupplier portal, you do not need to resubmit the Poland Prequalification Questionnaire again.  6. The Request for Quotation (RFQ) document will be for three (3) Units. The terms and conditions of the RFQ document will apply equally to three (3) Units except that certain separate requirements shall apply to each Unit.
 7. The TI Equipment scope shall include the design, engineering, furnishing, delivery, and testing and commissioning of Steam Turbine with Auxiliaries and Accessories; Turbine Supervisory and Governing Supervisory Systems; Turbine Protection System; Generator with Auxiliaries and Accessories , Moisture Separator Reheaters (MSR); MSR Drain Pumps, water-cooled Condenser including accessories; Condenser Vacuum Pumps and steam ejectors, Condenser Tube Cleaning System, LP and HP Feedwater Heaters; Feedwater Storage tank and Deaerator,;

and Steam turbine By-Pass Equipment; for each Unit of the Project.

8. The RFQ document will require furnishing of Parent Company Guaranty if the prequalified Supplier is an affiliate of Parent Company.

9. Proposal will be requested in EURO, PLN (Polish Zloty), USD and other currencies as may be approved by purchaser.

Furthermore, the proposals will be requested in a combination of Fixed Price (not subject to any price adjustment) and Firm Price (subject to adjustment per mutually agreed upon indices).

10. The Owner contemplates that it will obtain financing for the Project from financing parties, under which the corresponding financial indebtedness may be secured against all or a portion of the Project.

11. The evaluation criteria will include price, technical requirements, experience in furnishing similar equipment, commercial requirements, performance, and conformance with the terms and conditions.

12. Any Companies that do not meet mandatory compliance requirements will be excluded.
