The delivery times are agreed with the chosen supplier separately. However, at least 30 capsules must be delivered before 30.6.2024. The product must be designed and suitable for the transportation of patient with contagious infectious disease from demanding field environment (e.g. demanding terrain, cruise ship) to a primary health care facility with e.g. ambulance, truck, helicopter or boat. The product must be CE marked as a medical device. The product must have self-supporting structure or a built-in stretcher, or alternatively a separate compatible carrier stretcher must be included in the unit price. The product must work in negative pressure mode and positive pressure mode with possibility to change the mode. Other minimum requirements are listed in the Annex of this Request for Proposal.
